On Oct. 17, members of SAFE's PRIDE Project Coalition's Community Committee presented at the New York Highway Safety Annual Fall Symposium in Hauppauge, New York. Sgt. Chris Ortiz of the Glen Cove Police Department and Dr. Sharon Harris, executive director of SAFE, Inc. presented a cadre of collaborative activities the Committee has initiated regarding alcohol and substance abuse prevention, education, enforcement, and prosecution. The presentation highlighted statistics on underage drinking in Glen Cove per the 2010 Bach-Harrison Prevention Needs Assessment administered to students in sixth, eighth, tenth and 12th grades as well as Enforcement Details that include vendor compliance and social hosting. The 2010 Bach-Harrison results revealed that 20 percent of high school seniors reported either driving a car after drinking or riding in a car with a driver who had
